ELIGIBILITY AND INSTRUCTIONS FOR COMPLETING THIS FORM *(Please read)*

- ❖ Equipment must be purchased & connected to grid in 2017.
- ❖ Installed equipment must be on Polk Burnett’s lines.
- ❖ A site assessment is strongly recommended by a site assessor certified by the Midwest Renewable Energy Association(MREA) Visit www.the-mrea.org for a list of certified site assessors.
- ❖ Submit a copy of the site assessment with the co-generation application form.
- ❖ PV solar projects must be installed by a contractor with NABCEP certification or is working toward certification.
- ❖ PV solar equipment must be UL listed and commercially available.
- ❖ Wind turbine eligibility – approved wind turbines can be found at www.smallwindcertification.org
- ❖ Rebate for wind and solar projects are capped at \$750 per project; **call first to make sure there are still funds available.**
- ❖ Rebates are in place through December 31, 2017 or until funds are depleted.
- ❖ Rebates will be issued as a check 8-12 weeks after approval.
- ❖ Submit a copy of the rebate form and a copy of your detailed invoice **no later than 6 months after grid connection or January 2, 2018, whichever comes first.** However, members are encouraged to submit as soon as possible to ensure rebate:
 - ✓ This rebate form
 - ✓ A copy of your dated receipt or invoice
